



## TERMS OF USE

The Sigma Theta Tau International Honor Society of Nursing (Sigma) has established the following terms of use we expect all visitors, whether registered or not, to follow while on our site. Your continued use of our site means that you acknowledge these terms of use and agree to abide by them. Because we reserve the right to modify these terms of use at any time without notice to you, please check them regularly. Please note that you will be referred to as "user" from time to time in this agreement.

### General Rules
